

Letter of commitment to comply with the COVID-19 Safety Measures during the 2022 Surf City El Salvador ISA World Junior Surfing Championship

Applies to ALL participants (athletes, coaching staff, accompanying international visitors, ISA staff, local staff, suppliers).

I, _____ a national of _____ with DUI/Passport number _____, in compliance with the International Health Regulations (<https://www.who.int/ihr/publications/9789241580496/es/>), as well as with the provisions of Article 31. - Sanitary measures, related to the entry of travelers; hereby commit myself to faithfully comply with the biosecurity measures established by the International Surfing Association, before, during and after the event, to be held from May 27th to June 5th, 2022, in El Salvador being the following:

1. Provide the ISA with either a proof of full COVID-19 vaccination and/or a negative COVID-19 PCR test that was taken within 72 hours of initial arrival to the event site.
2. Comply with any current, or eventual COVID-19 protocols mandated for entry into the Republic of El Salvador;
3. Remain within the social bubble, cluster or group to which I was assigned whenever possible;
 - a. This includes not attending parties and/or social gathering, unless they are officially part of the event.
4. Comply with any biosecurity protocols to be implemented by the organization before, during and after the event and general indications regarding biosecurity such as:
 - a. Correct and consistent use of accreditation (and wristband) until the end of the event,
 - b. Correct and consistent use of a mask, namely,
 - i. Mandated for all indoor activities, and specifically for the Managers' Meeting.
 - ii. Recommended in all areas on the event site when in close proximity to others.
 - c. Frequent hand washing and use of sanitizing alcohol gel,
 - d. Maintain social distancing of 6ft (2m) whenever possible.
5. Allow health care personnel to take my temperature on a periodic basis or whenever necessary
6. If according to my symptomatology, or if the results of a SARS-COV-2 PCR test are positive, I agree to comply with the indications of health personnel, to not go to the event site, to not be in close contact with event participants, and to self-isolate until I receive a negative SARS-COV-2 PCR test and no longer have symptoms.
7. In case of presenting COVID-19 symptoms (including a cough, shortness of breath, or difficulty breathing, fever, chills, muscle pain, sore throat, and/or loss of taste or smell) I will immediately notify the ISA Medical Officer (medical@isasurf.org), self-isolate, receive a COVID-19 test, and notify the ISA Medical Officer (medical@isasurf.org) of the results. I agree to remain in isolation (for the period of time stipulated by the host country directions) until given clearance by the ISA Medical Officer or his designee.
8. The costs of lodging and food derived from a mandatory quarantine or self-isolation due to COVID-19 in El Salvador, will be my sole responsibility (or that of my team).
9. I understand that any specific COVID Protocols required for the re-entry into my home country, as well as any related costs for testing, etc. shall be my sole responsibility.
10. I confirm that I understand the ISA Rulebook, and the above specific ISA COVID-19 rules being implemented for the 2022 Surf City El Salvador ISA World Junior Surfing Championship. I understand that failure to abide by the policies set forth could result with penalties including, but not limited to, fines, removal of accreditation, and disqualification.
